Spotlight

On February 15, 2022, Cornell University announced the update of <u>Policy 4.21</u>, <u>the Research Data Retention policy</u>.

In their email, Emmanuel Giannelis (Vice President for Research & Innovation) and Hugh Hemmings (Senior Associate Dean for Research) explained, "*Policy 4.21 helps clarify the shared responsibilities of the University and researchers in the collecting, retaining, securing, accessing, publishing, and sharing of research data.*" They reminded all researchers that they are required to review the policy, and <u>compete an attestation</u> confirming they understand the provisions and their responsibilities to it.
