PLOS Open Science Indicators: Trends in preprint, data, and code sharing, 2019-2022

PLOS recently introduced [Open Science Indicators \(OSIs\)](#), a large public dataset identifying and quantifying Open Science practices like preprint posting, data sharing and code sharing in PLOS

articles, as well as a selection of comparator articles published elsewhere. The latest results continue to show incremental growth in all three areas.
