## Funder and Publisher News

### **Enhancements to the Research.gov Proposal Submission System, NSF Public Access Repository, and NSF.gov Award Search**

Effective November 22, 2021, NSF announced improvements to the Research.gov Proposal Submission System, NSF Public Access Repository, and NSF.gov Award Search. The changes most relevant to data include the ability to include metadata for NSF-funded datasets in the Public Access Repository (PAR) and associate them with NSF Award IDs as part of a PAR 2.0 pilot. NSF-PAR (<https://par.nsf.gov/>) will be accepting dataset metadata and DOIs on a **voluntary** basis through calendar year 2022; there are no changes to requirements at this time. ### **NIH Issues RFI on Proposed Updates and Long-Term Considerations for the NIH Genomic Data Sharing Policy**

On November 30, 2021, NIH published a [Request for Information](#) (RFI) on updates to the NIH Genomic Data Sharing (GDS) Policy. Comments will be accepted through **February 28, 2022**. NIH will use the responses to the RFI to consider options to update the GDS Policy and to harmonize with the NIH Data Management and Sharing Policy.
