The Data Science and Literacy Act of 2023

The [Data Science and Literacy Act of 2023](#) is proposed bipartisan legislation that would support increased access to data science and literacy education. The American Statistical Association is coordinating support and education around the bill. The act supports a voluntary program at the Department of Education through which educational entities (from elementary to two- and four-year colleges) could apply for funding to increase access to data science and literacy education.
